

## Macro-economic situation

- 3rd biggest economy of the world
- GDP/Capita in 2021: USD 39k (NL: USD 57k)
- GPD growth 1.4% in 2022
- Inflation rate: 2.5% (2022 yoy)



- National debt: ¥ 1,290,000,000,000,000 as of 2023 (about EUR 100.000 per person)
- Aggressive monetary and fiscal easing policies by Bank of Japan
- Unemployment rate: 2.40 % (January 2023)
- Annual 3,59% of GDP investment in R&D in 2021 (\$ 151 bln, 80% in private sector)

## Concerns linked to macro-economy in Japan


- Geopolitical risks
  - Neighbouring with China (Taiwan) & Russia (war in Ukraine)
  - Nuclear threats by DPRK
  - Relations with South-Korea is being restored after Pres. Yoon.
- Reducing strategic dependencies (semicon, critical raw materials, health, communication)
- Doubling of defence budget
- New President of BoJ Mr. Kazuo Ueda
- Cost-push inflation (consumer prices up, but payroll not increased; although SEGA recently increased salaries by average of 15%; Uniqlo up to 40% salary increase)

## An Ageing Society

Population changes

- Total elderly population (age >65) is 36.4 million (29.1% of total) in 2021
- YoY + 220,000 elderly people
- Total Japanese population: YoY -510,000

Expenditure and "income"

- 22.97 trillion yen (or EUR 159 bn) spent on elderly care in 2022
- "Ageless working society", "Silver manpower" many people are entrepreneur in second life as part of healthy aging
- 9.06 million elderly people still hold jobs; income generation = 13.22 trillion yen

Elderly care statistics

- Number of nursing homes (2021): 13,731 (accommodating elderlies)
- Number of homecare service stations (2021): 121,502 (visit-type services)

Policies

- Japanese government set up "Healthcare Innovation Hub" in 2019 to provide consultations to start-ups in relevant industries.
- Japanese efforts for improving elderly care tends to utilize ICT, less human-centric than Netherlands.
- High interest in Dutch elderly care models and approach to dementia (bilateral consultations, Buurtzorg, Hogeweyk)









#### **Opportunities**

- Plenty of business opportunities
  - ► Volume for products and services is high
  - ► Solid financial environment
  - ► Sensitive to added value and high quality
- Clients are demanding but margins can be healthy
- Once a relationship is built, it will last long
- ▶ Japan may be difficult to enter for your competition
- Skilled and hard-working workforce
- ▶ Japan business environment becoming more foreigner friendly
- Japan as a hub to other Asian countries
  - ► Japan as regional HQ
  - ▶ Follow Japanese companies in their overseas business

#### Challenges

- ▶ It takes time to create business, patience and perseverance required
- Conservative mindset, avoiding risks
  - ▶ Technology must be proven, track record is important
- Details vs total picture
- Contracts are thin, business based on trust
- Decision making is challenging
  - ▶ Business is hierarchical and consensus is required
- Understanding each other (common language is not always enough)
- Japan has its own way of doing things
  - ► Certifications, laws, etc.
  - Galápagos Syndrome\*




